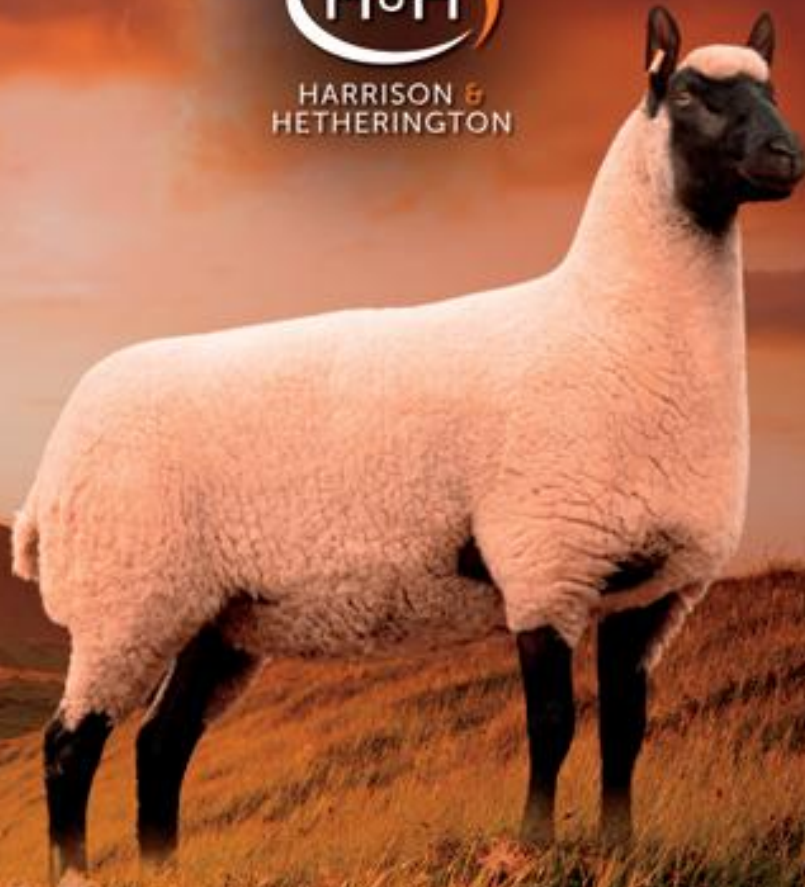

- Payment is due in full on day of purchase.
- Interest is chargeable from date of purchase for accounts in default.
- Accepted form of payments: Debit card or direct bank transfer. A 2% surcharge will apply to business credit card payments. If payment is made by credit card, it must be linked to a business bank account.
- Anti Money Laundering (AML) & Cash Payments For avoidance of doubt our company AML policy is to accept a maximum of £1,000.00 per trading account per year.

Judging will commence at 8:00am and take place in the following order:

Aged/Shearling ewe, Ewe lamb, Aged/Shearling Ram, Ram Lamb. Trophies kindly donated by P&L Murray for the Champion Female and Champion Male.

LOCATION - The Sale will be held at Borderway Mart, Carlisle.

VIEWING - The Sale Sheep will be available for inspection on the morning of the sale. Prior inspection of the sheep is most welcome by appointment with the vendors.

CONDITIONS OF SALE - Sold under the conditions of sale subject to the Livestock Auctioneers Association.

METHOD OF SALE - All sheep will be sold in guineas (105 pence) and strictly in catalogue order, unless any alteration is announced by the Auctioneers. A Commission of 5.5% will be charged on all sheep sold.

COMMISSIONS - The Auctioneers will dutifully execute commissions to purchase for buyers unable to attend the sale personally, upon receipt of written instructions.

SETTLEMENT AND CLEARANCE OF STOCK - Settlement in full is due immediately at the close of Sale. No animal may leave the Sale Premises without an official 'Pass Slip', obtainable only from the Auctioneers upon settlement.

CLUN FOREST SHEEP BREEDERS' SOCIETY REGULATIONS FOR SALES

1. All lots will be sold strictly to catalogue order regardless of judging results.
2. All animals must be earmarked in accordance with the Society's and DEFRA regulations. Each animal presented individually for sale must be clearly identified with the appropriate lot number. It is the Vendor's responsibility to ensure that all ear tag numbers are correct and agree with the printed catalogue and CFSBS registration details.
3. Any error of description in the catalogue will be notified and announced by the Auctioneer at the time of sale.
4. Breeders/vendors are responsible for the registration of all entries in the Society's Flock Book. All lambs (male and female) born in the same year as the sale must be registered with the Society by the Vendor in the Flock Book for that year.
5. Vendors should notify reserve prices to the Auctioneers before the start of the sale. Animals for which no notification has been given will be presumed for sale without reserve.
6. All animals entered or exposed for sale must be the bona fide property of the vendor at the time of entry to the sale and be free of liens, charges, and incumbents.
7. Vendors must be current members of the Clun Forest Sheep Breeders Society before entering animals for sale.
8. Each animal forward at the sale must be exposed for sale by auction before any private sale shall be permitted or recognised by the Auctioneers.
9. All animals must be forward on the day of sale if possible.
10. All members presenting sheep for sale must have adequate public liability insurance.
11. Substitutions are strictly only allowed to replace animals that have been taken ill, are injured or died. A sheep may be substituted for an original entry provided it is in the same class. The substitute's pen must be clearly marked and include details of the animal's dam and sire clearly available for potential purchasers to see. The Auctioneers must be informed of the change so that a clear announcement can be made when the substitute animal is offered for sale.
12. Any additional animals, which do not meet the above criteria will be treated as late entries and offered for sale after the scheduled lots.
13. Bio-security – precautions relating to the segregation of MV Accredited stock must be followed at all times.
14. Movement Licences – Intending Purchasers should have their CPH number ready to supply the Auctioneers so that the correct movement licence may be issued before departure from the market. Vendors and purchasers must comply with current DEFRA regulations for Animal Movements in force at the time of the sale.
16. No sheep will be allowed to depart from the market without a licence from the auctioneer's office
